Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Deconcentration and Other Policies that Govern Eligibility, Selection, and Admissions.

The PCHRC will consider determining applicants with Felony Convictions as eligible for housing if they are participating in Rebound or a South Dakota Unified Judicial System-approved treatment court, such as, but not limited to, Pennington County Drug, DUI, or Veterans Courts.

Homeownership Programs.

The PCHRC has been approached about implementing a homeownership program with VASH vouchers. The PCHRC will work with the VA to determine if this program is a feasible and beneficial use of VASH vouchers. If so, the PCHRC will establish a homeownership program for VASH vouchers.

Financial Resources:

The Statement of Financial Resources has been updated and is on file in the office.

Rent Determination:

Section 8 Voucher Payment Standards were reviewed and revised based on HUD published Fair market Rents (FMRs). Payment Standards are set between 90% and 110% of the FMRs according to HUD regulations. They will be monitored and revised as necessary to remain in compliance with HUD regulations or to ensure an adequate supply of rental housing is available to Section 8 participants.

Public Housing Flat Rents are set at approximately 100% of HUD published Fair Market Rents (FMRs) with the exceptions of Prairie Village and Edwards Manor, which are set at approximately 80% of FMRs.

Significant Amendment/Modification

As part of the Rental Assistance Demonstration (RAD), PCHRC is redefining the definition of a substantial deviation from the PHA Plan to exclude the following RAD-specific items:

- a. The decision to convert to either Project Based Rental Assistance or Project Based Voucher Assistance;
- b. Changes to the Capital Fund Budget produced as a result of each approved RAD Conversion, regardless of whether the proposed conversion will include use of additional Capital Funds;
- c. Changes to the construction and rehabilitation plan for each approved RAD conversion; and
- d. Changes to the financing structure for each approved RAD conversion.

The PCHRC is seeking to develop (70) additional affordable housing units. Mixed Finance Development may be utilized.

Demolition and/or Disposition. (Section 18)

The PCHRC plans to pursue Section 18 Disposition and RAD/Section 18 Blends in following guidance in PIH Notice 2021-07 because it will allow the PCHRC to receive needed additional resources.

PCHRC plans to submit a Section 18 Disposition application for 35 non-contiguous scattered sites. The sites will be sold at fair market value and proceeds used to further repositioning and new affordable housing development goals.

Following PIH Notice 2021-07 and 24 CFR 970.17(c), the PHA has otherwise determined the disposition to be appropriate for reasons that are consistent with the goals of the PHA and the PHA Plan and that are otherwise consistent with the Housing Act of 1937. Due to distance between units and lack of uniformity of systems for the non-contiguous scattered sites, the PHA determined it unsustainable to operate and/or maintain the units as public housing.

Conversion of Public Housing to Tenant Based Assistance

In conjunction with RAD project developments, the PCHRC may apply for Tenant Protection Vouchers (TPV). Generally, replacement TPVs will be issued based on the occupancy of the public housing units being removed through Section 18. The Section 18 RAD Small Agency Blend Rule and Section 18 Disposition of scattered sites would provide PCHRC with needed additional resources for Tenant Based Assistance relative to repositioning and RAD conversion of units.

Conversion of Public Housing to Project-Based Rental Assistance or Project-Based Vouchers under RAD.

The PCHRC will investigate current HUD Asset Repositioning programs for the purpose of selling some of its scattered site single family homes to finance multifamily developments.

1. Consideration will be given for a Section 18 application under Asset Repositioning with an expected timetable in 2023 and 2024.
2. Consideration will be given for a RAD application under Asset Repositioning with an expectation to pursue such repositioning following a Section 18 disposition.
3. Consideration will be given for a Demolition/Disposition application.

The PCHRC will investigate current HUD Asset Repositioning programs for the purpose of redeveloping a (37) unit complex.

1. Consideration will be given for a Section 18 application under Asset Repositioning with an expected timetable in 2023 and 2024.
2. Consideration will be given for a RAD application under Asset Repositioning with an expectation to pursue such repositioning following a Section 18 disposition.
3. Consideration will be given for a Demolition/Disposition application.

The PCHRC plans to participate in the Rental Assistance Demonstration (RAD) program. As a result, the PCHRC will be converting to Project Based Vouchers under the guidelines of PIH 2019-23, REV-4 and any successor Notices. Upon conversion to Project Based Vouchers the Authority will adopt the resident rights, participation, waiting list and grievance procedures listed in Section 1.6 of PIH 2019-23, REV-4; and PIH-2016-17. These resident rights, participation, waiting list and grievance procedures are appended to this Attachment. Additionally, the PCHRC certifies that it is currently compliant with all fair housing and civil rights requirements.

RAD was designed by HUD to assist in addressing the capital needs of public housing by providing PCHRC with access to private sources of capital to repair and preserve its affordable housing assets. Please be aware that upon conversion, the Authority’s Capital Fund Budget will be reduced by the pro rata share of Public Housing Developments converted as part of the Demonstration, and that PCHRC may also borrow funds to address their capital needs. The PCHRC may also contribute Operating Reserves in the range of \$XXX-\$XXX and/or Capital Funds in the range of \$XXX-\$XXX towards the conversion.

The PCHRC has been moving forward with a plan to develop (70) units for families at or below 80% AMI. Schematic design has been completed and additional financial resources from the County have been secured in the amount of \$2,000,000. HUD Technical Assistance was received on the topic of Asset Repositioning in 2021-2022.

The PCHRC produces and distributes Landlord/Property Manager Handbooks to provide information on the Section 8 program to prospective landlords. Outreach is conducted through membership in the Black Hills Multifamily Housing Association.
